Sustained Freedom Project – Bihar

The *Sustained Freedom Project* was focus on reducing the prevalence of human trafficking through a *Nyay Kendra* (a. k. a 'Justice Hub') Supported through intensive legal training programs, sensitization and awareness events. The project focuses on helping trafficked victims through the following interventions:

This year, we rescued 14 minor victims trafficked for commercial sexual exploitation purposes from Different districts of Bihar. About 17 accused were arrested. 3 Child labour also rescued. We also did aftercare work closely towards the rehabilitation, reintegration and restoration of rescued victims. We organized several **capacitybuilding training and advocacy programs** for strengthening government and community stakeholders. For capacity building we did many virtual and physical training program with PRI members, School teachers, Police officials, AHTU, DCPU, CWC's, PLV's, SSB etc. We also trained Anganwadi workers,

Mukhia, ward members and other panchayat level stakeholders on **Laws, Procedures & Welfare Schemes for Rehabilitation of Survivors of human trafficking**. A series of workshops, meetings and capacity building programs was organized with team members. We also organised many meetings with different government officials and child line for rehabilitation of trafficked victims.

A series of awareness programs was organised by Adithion the occasion of "Aajadi Ka Amrit Mahotsav" many **Legal Awareness Program** was organised with Collaboration with District Legal Service Authority, Sitamarhi and JVI in which 288 participants were attended the program and 49 village level program was organised in which total 3063 participants were attended the program (1644 women, 554 men, 577 girls and 288 boys).

1. Village level awareness program done by our team. Initially our team worked with PLVs after that our team continuously worked on these issues regularly by themselves. When ever they visited in villages for group

meetings, they also talk with them about free legal support. They created awareness among community as a result of following things were seen -

- Presentation of women was very good total 1644 women attended the event
- Girls and boys were also presented in the awareness program
- We visited door to door in 41 villages of 5 blocks
- During awareness program women had shared many cases related to Indira Aawas, old age pension, violence cases, Pocsos cases, wife beating, dowry cases, child labour etc. have come during awareness programs,



5000 brochures were printed and distributed to community members, PLVs (DLSA) - 500, CWC, different government departments and NGOs

In this year we have following aftercare reflection

The functions of the Nyay Kendra are continuously expanding. There has been a lot of awareness among the people about Nyay Kendra. Women and men from remote rural areas of the district are coming to the Nyay Kendra and sharing their problems and they are being guided. The process of intervention in various cases is being done through Nyay Kendra. Due to which people's opinion is changing and people have got a lot of trust in Nyay Kendra. Many victims are connected with the mainstream of the society through Nyay Kendra. Many cases have been solved through Nyay Kendra. In which the people from the lowest stage of the society have been greatly affected and their thinking has changed. They have become very aware of their rights and raise their own problems. A special training program was organized with the SSB and the potential thinking, work

experiences and interventions. Experiences in various cases were shared among the participants. During the community meeting also shared experiences on the above points. Shared experiences while participating in monthly meetings of CHILDLINE and Intervention was also taken in different cases under CHILDLINE and the cases were executed giving cooperation.

- (a) To get the government compensation and schemes for the rescued girl, victim's was presented before the DLSA and court. During the all procedure the relations were expanded with the above officials.
- (b) A request was made through a letter to present the victims living in the different homes of different districts and during this the relationship was expanded.
- (c) Child related issues solved with the collaboration of DLSA, CWC, Labour Department and other such institutions, which are working for children and their cooperation was also obtained. Work was also expanded, improving relations with them.

ChildLine Support Program as Nodal

Adithi is supporting CHILDLINE as NODAL organisation from June 2011 in the district Sitamarhi. The main role is to develop synergy and coordinating effort with line department, institutions, organizations, SSB, Rail police and also with cross boarder organisations etc in the direction for protection, prevention and prosecution in favour of children. In Sitamarhi there are more three organizations also working in the role of collaborating organisation and sub-centers and our role is to support and develop coordination, collaboration linkages and capacity building of these organisations to support children and stop child atrocities/any type of crime/ violence with children in the district Sitamarhi.

The main activities are:

1. Coordination of CHILDLINE at city level (number of meetings conducted and issues discussed): following are activities to fulfill the initiatives:

- ✓ Weekly Meetings with team members: 10 meetings.
- ✓ Monthly Meetings with team members: 12
- ✓ Co-ordinators' Meetings: 6
- ✓ Directors meetings organised-2

Major discussions are as follows:

- Coordination with RPF GRP SSB police department.
- CSA Issues, etc.

Coordination with the Government

Child marriage also one of the major challenges

Recovery Work in India in Light of the Impact of COVID-19

The Project is being implemented in 70 villages of Sitamarhi, Siwan and Gopalganj districts with support from The British Asian Trust. The progress in the reporting period has been as hereunder:

The access to Ayushman Card is very low in Sitamarhi, Siwan and Gopalganj and the penetration is even grimmer in remote areas where the most marginalised population lives in. So, Adithi worked with Sitamarhi district administration and supported them to increase their reach especially in remote and marginalised community who are more in need for medical insurance in case of emergency. Through this effort the reach has increased for health department additional 98,881 additional Ayushman Cards generated across three districts with efforts from Adithi.

Our targeted families are aware and the coverage of covid vaccines is 33,696 persons (adult/adolescent/children) in targeted

7blocks through the convergence efforts of ADITHI with Govt. departments.

After COVID-19, the education system was affected. To ensure RTE, 35 SMCs and community were made aware, and 38 letters sent to Education Minister and District Education Officer covering all the relevant demand. Education minister and state officials released a letter to DEO then district officials also released letters to the district and block. This supported to ensure selection of 80 % SMCs in all 3 districts. ADITHI supported 2416 children directly under the project for their education which includes providing learning materials, school uniforms and scholarships from Govt. MNREGA and Jeevika: 887 got job cards and Jeevikasupport for starting for their business. In the project districts DCPC meeting was not regular so with efforts from ADITHI DCPC meeting was regularised and they also directed to continue the Block CPC meeting on regular basis. In the reporting period 20 children

received support under Parvarish Scheme from Social Welfare Department.

ADITHI has also promoted labour forum in their project district which has resulted to get work for 16, 106 persons across 25 Panchayats and 7 blocks.

ADITHI is also working on increasing the effectiveness of govt. services and entitlements and in this reporting, period following additional services reached to the marginalised families:

Old Age Pension: 223

Housing Scheme: 156

Ration Card under PDS: 592

Labour Registration: 832

Birth Certificate: 510

E-Shram Card: 1529

133 CBOs from 70 villages played a major role for helping families to accessing these schemes and ADITHI were instrumental to facilitate the process.



Narrative Report on Project Components:

❖ Component 1 (Community Interface)

816 members of labour forum of 67 villages oriented and the members are



keeping their demands to digitalise the work demand to the concerned officials at the district and block level in three districts. They were oriented to plan their initiatives accordingly. MGNREGA should provide for demand for work online or on digital platforms so that people of the community have easy access. This demand taken in consent by the officials. It will be helping to facilitate the process for generating demand and creating visibility for their work demand at state level. As of now 3324

Job card holders were enlisted across district who have potential for child labour and the families of school dropout children to support accordingly and strengthening labour forum for work demand.

1023 persons of SMC, champions, and freedom group of targeted 70 villages and 35 schools oriented. 38 Letter writing campaign was organised and send a demand letter to education minister and district education officer for selection/ orientation/ responsible to SMC for child protection from child labour and stop drop out of children.. State education department has also sent circulars for SMC selection. The same was initiated by block officers. As a result, 80% SMC was constituted in three districts.

❖ **Component 2**

(Data collection / information gathering/ Planning)

Activities and change achieved

Based on the report received from the survey conducted on five issues in the past with the technical support of Praxis, all the partner organizations prepared documents for advocacy at the district and state level. State fact

sheets and other campaign on MNREGA, education, GPDP, Child protection/ DCPC and Health/ Ayushman has planned accordingly.

All the documents prepared and are shared with each other. We have organised a district meeting with stakeholders on status of child labour and education. For tracking of online work demand, a tracking tool has been created through Kobotool by the joint initiative of all the partner organizations to track work demand in MGNREGA, procurement, etc. There is an action plan to use it as evidence, etc., so that our *Kaam Mango Kaam Pao* campaign can be further strengthened.

Component 3

(Networking with CSOs)

Activities and change achieved

Jointly organised at 3 district level interface along with 78 persons local CSOs, CACL, CCHT, HLN and RTE Forum, etc, so as to ensure a joint initiative on education. It has been decided include and mandate child labour and child protection in the SMCs work agenda. We also shared the State and District level PRAXIS report in the said meeting and

incorporated their views in our programme which gave us a lot of strength in the letter writing campaign.

SCPC, Bihar called a meeting with HLN partner and other CSOs on regularising of Child protection committees at Block, and ward level. We have spoken about the convergence with the departments.

❖ Component 4
(Government Interface)

Activities and change achieved

The 38 champions interfaced with 290 officials at block / district officers for the protection of children, enrolment of most deprived child, S.M.C. selection, to Include fund for Child protection and digitalization of demand. A letter was given to them on these issues.



Members of labour forums of all the 7 blocks met the block level functionaries and demanded online or digital arrangements to provide work in MGNREGA. As a result 16106 labour got work in 7 blocks.

DCPC meeting was regularised in two districts. In Sitamarhi it was regularised after 2 yrs. A calendar of date circulated to regularise all block level CPC and it was done and oriented to all member of the committee by DCPU.

❖ Component 5



(Coordinated and joint activities)

Activities and change achieved

Joint initiatives of SMC / Champions initiated and letter writing campaign by SMC and that got response from Education Minister to state and district officials to increase the effectiveness for educational supported schemes.

During election of PRI, HLN prepared Shapathpatra and took it signed by the 259 candidates from 18 Panchayat and 35 villages, in which they have agreement on 5 demands after their win they will work on Child protection. Letter campaign done by community to include untied fund for child protection in GPDP and 12 Mukhiyas/ Gram Pradhan also wrote a letter to DPRO for the same.

By the joint effort of Champions and community people 132 Health camps

for Ayushman and covid vaccination organised in 3 districts. Among them 33696 person vaccinated in 7 blocks.

The champion members had submitted a memorandum to the Department of Social Welfare and Labour Resources for inclusion of child labour prohibition and child protection in the GPDP so as to ensure that the initiative at department level could be ensured.



Preventing and Responding to Child Marriage & Early Unions

In our grant proposal, we had set our overall goal as 'Raising girls' physical, mental and intellectual wellbeing and their status in family and society.'



We can say with all satisfaction that we have built further in the last 12-month upon the firm foundation laid before. Our girls have shown a transformative change in every field specified under the goal, and their status have definitely gone appreciably up in their families and community. They have become increasingly conscious of their value and role in their families that has effectively replaced the former perpetual sense of inferiority in their minds. What is important, they have gained awareness about their rights and entitlements and strength and

agency, both individual and collective, to realize the same. Additionally, they are very much conscious that during the past project phases we have been able to erect a firm and unfailing institutional mechanism to provide them the needed support that have infused them with a new confidence.

They now find that the familial and community environment had never been more favorable to them in as much as there is an increasing realization that the education of girls is important as anything else and there exists an eminently enabling environment for them to get educated and stand on their own feet if they choose so. They have gained the capacity to be an active participant in all their individual or family affairs, take informed decisions about their life and its choices and get the same implemented.

A brief summary of the activities your organization conducted while working directly with girls over the last 12 - months:

❖ *Imparting leadership training:*

This year we reconstituted 5 adolescent girls' clubs with 11 to 18-yr age-group 500 girls and worked with them under various activities there. These girls were trained through a total of 44 training sessions on a number of relevant leadership topics. They, in their turn, discussed these topics with other girls of their villages and became their peer educators. They were provided further support through organizing a total of 404 follow-up meetings with small number of girls (totalling 3218 girls) in each hamlet wherein the peer educators participated along with their peers for doubt solving through further discussions with their mentor (the Organizational Animator). We did also organize five interfaces comprising of 92 girls with 23 Panchayat office-bearers and Government officials that effectively enhanced their self-confidence to put their issues before them and get them addressed.

❖ *Training in earning skills:*

We attempted to enable the girls gain earning capabilities by learning skills like incense sticks making (116 girls), hand pump repairing (35 girls) and Mushroom Cultivation (18 girls). Under the Kitchen gardening, improved seeds of vegetables were distributed among 325 girls. We did also provide training to 217 interested girls in Sewing & Cutting on their demand. In addition to it, we also took benefit of vocational trainings under the Government sponsored DDU-GKY with the details as hereunder: ANM- 5 girls; Nursing- 50 girls; Warehouse Employees- 14 girls; Electrician- 5 girls; Automobile Fitter- 1 girl, Sewing Machine - 102 girls, Weldor-12 girls. 29 girls of them have already got jobs and are self-dependent economically.

>Supporting girls' education:

From during the COVID-19 lockdown, we have been running free tuition classes for 287 girls for all classes from 2 to 10. In addition to the above, we have also facilitated the 15 eligible



girls' admission in IGNOU and local college.

❖ *Boys' Gender Sensitization:*

This activity was mooted as providing an additional support to the adolescent girls struggling to find their rightful place in their family and community. It was also aimed to quicken the pace of the change in familial and societal attitude towards girls and women and their empowerment efforts. This sensitization revolved round the following topics: Adolescence and physical changes during it, gender and gender Discrimination, sex & homosexuality, responsibilities of manhood and womanhood, patriarchy and its attitude, child marriage & ways to reduce it, status of girls and boys' role in it, how to avail skill training opportunities, re-enrolment of dropped-out children, boys' role in changing society, etc. The activity was successful to meet its object of changing the boys' mental orientation from being on a superior pedestal to a position at par withor, at least, only marginally superior than the girls. This was a big leap forward for a society steeped in patriarchal mindset.

Though we had aimed to provide the sensitization to only 150 number of selected adolescent boys in 11 to 18-age-group, but due to the intervention's immense benefits observed in the families and the community, gradually, were able to provide it to a total of 867 boys through a series of 56 sensitization sessions during last 12 months. But, that was not all. Like the leadership training to girls, we also made it a point to organize follow-up sessions with these sensitized boys for the ideas learnt during the sensitization to take firm roots and not wither away with time. Through a total of 278 these follow-up sensitization, we worked and reworked,cumulatively, with 1927 number of boys.

A brief summary of the activities your organization conducted while working directly with parentsand/or family members over the last 12-months:

This activity was initiated to come into the direct contacts of the parents and other family members of the targeted girls for both having a direct communication with them and also identifying their eligibility for various

Government schemes. A large numbers of such unreached eligibilities were identified and they were provided the necessary information and facilitation.

A cumulative total of 2540 households were visited by our project workers during the last 12 months resulting in accrual of quite a number of entitlements due to them:

❖ *Community Meetings:*

We have been meeting the parents through the Community meetings also where we discuss so many issues with them and impart information and awareness to them besides nudging them to change the traditional attitude about the patriarchy and gender thus facilitating in preventing child marriages and early unions. In this reporting period, we were able to conduct 137 such meetings in which a total of 2186 persons participated.

Organizing PRI members' meetings:

PRI members are the most important community leaders in the rural areas and as such, it has been important for us from the very beginning to have them on board. Through our diligent work in the community, we are happy to state that we have been able to impress them favourably. It was only with their support that we were able to accrue a number of benefits to our target group families. However, to

have an exclusive exchange of ideas we have been convening their meetings with us. In this reporting period, we organized nine such meetings with a total of 217 participants. We derived full benefit from these meetings like putting our issues concerning their areas of work to them and by also patiently listening to their viewpoints concerning our work and clarifying their misunderstandings, if any. In these meetings they also suggested to us several useful points that we noted and worked on.

Organizing stakeholders' meetings:

Similarly, we worked with other community leaders who are as important for our work like teachers, various service providers and other community leaders hailing from different sections of the community. So, like the PRI Members we planned to have exclusive talk with them as well by organizing their exclusive meetings with us.

We had nine such meetings with them in this reporting period with a total 265 such participants in which we

raised several issues concerning their respective areas of work and specialties and derived important suggestions while having our issues with them addressed and resolved.

In the above light, these meetings thus proved very useful and beneficial for us as well as our target groups.

The harmful gender and social norms that we have addressed in our working area through our project over the last 12-months:

Gender equality is achieved when all people have equality of opportunity, are free to develop their personal abilities, and are able to make choices so that they can realize their full rights and potential, without being limited by stereotypes, gender norms, or prejudices.

During the last 12-month period, we marched beyond addressing the child marriage and early union norms to enlighten the general scenario regarding girls' enabling environment without which further development of the targeted girls was just not possible.

Unless their educational and earning capabilities were addressed, they would have found path to their status up-gradation blocked that could also have mitigated our efforts done to fight child marriage and early unions. The community had a chronically harmful norm of placing the girls' education secondary to other pressing familial needs and always fought short of solving the constraints in this direction. We provided them the much needed support in this regard by presenting an alternative to prolonged school closures due to COVID-19 lockdowns in the form of starting free tuition classes exclusively for girls of the community.

In the same way, we also worked hard to improve the earning capabilities of the girls while that was not at all in the priority list of the parents who concerned themselves only to their getting married. While we provided skill trainings to the girls in various trades, we also strove much to get them acquiesce to send them to DDU-



GKY trainings and placement and were successful to a fair amount in comparison to the former negligible data concerning the same.

We also addressed the much harmful gender norm during the times of menstruation during which a girl/woman was not supposed to take bath, cook food or care for menstrual

hygiene for that matter. We fought this norm and through our persistent efforts have come a long way along improving the scenario to a significant extent. These myths and misconceptions were effectively fought against and menstrual hygiene was introduced in a big way.
